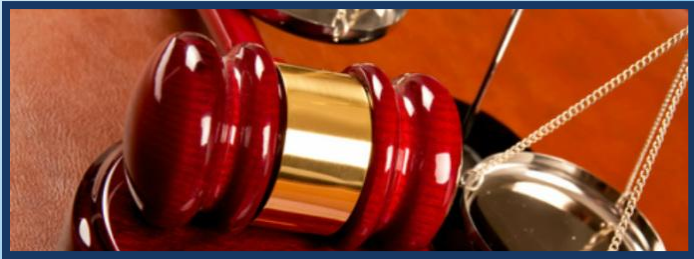


Donna Greenspan Solomon is a Certified Circuit, Family, and Appellate Mediator. Donna offers mediation services only to attorney-represented parties.
